We are continuing to receive claims arising out of wire fraud. In most of these instances, the buyer received a phishing email purportedly from the agent, which was not actually sent from the agent. That email provides wiring instructions for their deposit. The instructions are fraudulent and the wire is sent to some remote location out of the Country. I have re-circulated our Risk Management Tip regarding Wire Fraud. It is important that agents ensure that the buyers are aware of this issue and review the wire fraud advisory.
